### WAIVER AND RELEASE AGREEMENT

Please read carefully before signing. This is a release of liability and waiver of certain legal rights

In consideration for my being permitted to participate in the activities of Manchester Rod and Gun Club, Inc I agree to the following Waiver and Release:

I acknowledge that Shooting Firearms has inherent risks, hazards, and dangers for anyone that cannot be eliminated, particularly in a shooting range and shooting match. I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling, shooting firearms and being near others that have firearms in their possession;
2. The risk of injury from ammunition and bullets shot from other guns;

I understand the risks, hazards, and dangers of shooting firearms and have had the opportunity to discuss this with range officers. I understand that these activities may require good physical 'conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks involved. I AM VOLUNTARILY USING THE SERVICES OF Manchester Rod & Gun Club, Inc. WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.

Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS Manchester Rod & Gun Club, Inc., their directors, officers, agents, members, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, accidents of any kind or nature, whether foreseen or unforeseen, resulting directly or indirectly in any damage, loss, injury, paralysis, or death to me or my property as a result of my participating or being present in these activities or the use of these facilities whether such damage, loss, injury, paralysis, or death results from act or omission of Manchester Rod & Gun Club, Inc., their directors, officers, agents, members, and volunteers or from some other cause.
